Hello all and welcome to our latest newsletter.

Since our last edition we have seen cold spells, snow and annual festivities. In a flash, we are now into 2023 and I hope you managed to find some time to rest and recharge amidst continuing pressures throughout the system.

The end of last year saw us wrap two major projects designed to support our workforce: the CVD Fellowship Programme and Care Home Pioneers cohort four. Both projects are successful examples of our ongoing commitment to provide collaborative learning opportunities, develop technical and leadership skills and deliver real-world improvement projects which benefit the health and care workforce. 2023 at the HIN has started brightly, with outputs, learnings and insights from long-term projects becoming available across many of our clinical programmes.

We recently published a series of blogs on perinatal health inequalities, sharing recommendations for improving the birthing journeys of minoritised people. We have also been continuing our work on evaluating mental health crisis hubs across London, in collaboration with NHS England and Improvement.

We are pleased that our current license with NHS England will be extended for a further year until 1 April 2024. We will be supporting NHSE in discussions about the future of national programmes, and are excited about having an even greater impact on health outcomes through our local projects.

Our business planning cycle restarts shortly, and we are pleased to be building relationships with new partners across the health and care system in south London and beyond. Delivering impact through digital transformation is high on the agenda for many of our partners; it is great to be supporting a range of projects in this area, including the adoption of automation technology to save time in primary care, and reviewing how apps might help provide

### personalised care for people with cancer.

Winter will of course continue to be an extremely challenging period for many of us. We stand ready to support wherever we can – please do get in touch with me or the rest of the team to discuss how the HIN might be able to help.

## Cardiovascular Disease Prevention Fellowship

In April 2022 the HIN launched its CVD Prevention Fellowship Programme which upskilled 85 primary care clinicians in different areas of CVD and quality improvement. This programme consisted of a series of clinical webinars delivered by secondary care specialists from south London alongside QI training where Fellows carried out their own QI projects which saw improvements to CVD care in over 40 GP practices.

This was a very successful programme with 98 per cent of fellows feeling more confident delivering care to people at risk of CVD and 96 per cent supporting their colleagues more with CVD care.

#### **Mental Health Crisis Hubs**

We have published an evaluation of mental health crisis hubs. The hubs were set up during the pandemic to improve access to mental health crisis care without needing to go to emergency departments.

The report was designed with input from experts by experience, who also co-designed a <u>layperson summary</u> to ensure the findings are widely accessible.

### New Funding to Help Prevent Cardiovascular Disease

The Small Business Research Initiative (SBRI) has awarded a total of £3.3 million funding to support initiatives designed to tackle cardiovascular disease (CVD) in England. A portion of the national funding will be used to scale up initiatives in two projects to prevent CVD in south London: Healum patient management software and the CVD Prevention Decathlon.

We are looking forward to expanding our support for these programmes to minimise the risk posed by CVD for as many people as possible.

Healum provides software, patient facing mobile apps and systems to PCNs that enable them to support and empower patients at risk of CVD through self-care resources and patient care plans. Healum has secured central NHS funding for 30 practices in south London to use its product for one year.


#### What will be the benefits for your practice?

Healum's planning software and mobile app help reduce pressure on GP workforces, empower patients and improve health outcomes by sharing relevant educational content as part of a collaboratively created care-plan for patients at risk of CVD. The system is interoperable with EMIS and has been shown to improve patient engagement.

In the UK, Type 2 diabetes affects African and Caribbean communities at a higher rate than white European communities. To address this disparity, a type 2 diabetes self-management, and education programme called <a href="Healthy-Eating">Healthy-Eating</a> and Active Lifestyles for Diabetes (HEAL-D) was developed.


